

Here's Montgomery County's match



\$6 for **each \$1**
of the **first \$50**
of a qualifying contribution,
\$50 becomes **\$350**



\$4 for **each \$1**
of the **second \$50**
from \$50 to \$100,
\$50 becomes **\$250**



\$2 for **each \$1**
of the **third \$50**
from \$100 to \$150,
\$50 becomes **\$150**

NEW! Maximum contribution for the election cycle (primary and general combined) is **\$250**.

All contributions welcome but only contributions from Montgomery County residents will be matched from the Public Campaign Financing Fund. ***Contributor's signature is required to receive matching funds.** In the case of a credit card contribution, I also hereby affirm that this contribution is being made from my personal credit card account, billed to and paid by me as my contribution, and has no corporate or business affiliation.
